

1. Name and Address:-


- a) The name of the Society shall be "NEW SHIVALIK EDUCATIONAL & WELFARE SOCIETY."

- c) Area of Operation :- Mohali (Punjab) .


2. Aims & Objectives :-The Aims & Objectives of the Society shall be :-

- i) To spread quality education of international standard at easily affordable cost & establish, run manage , administer , finance , enter into franchise , collaboration for setting up schools, collages, academics, educational boards or institutions for imparting general , scientific , commercial , medical , engineering musical , vocational or any other type of education to the students orally regular through post or otherwise in India or Abroad .





- (xi) To apply the income and properties of the Society so derived solely towards the promotion of its objectives as set forth in the memorandum and no portion there of shall be transferred by way of dividend, bonus or otherwise by way of profits to its members.


1 INTERPRETATION:

In the interpretation of these of rules there is something with the subject context :-


- a) The Society means "NEW SHIVALIK EDUCATIONAL & WELFARE SOCIETY".
- b) Governing Body means the Managing Committee of the said Society .
- c) Member means the member of said Society.
- d) Year means the period commencing from 1st April and ending with the 31st March next year .
- e) Office bearer means the President , Vice- President , Gen-Secretary, Cashier, Auditor and Executive members for the being.


2 MEMBERSHIP

- a) Subject to provision of rule 3, any adult having faith in aims and Objectives abiding the rules and regulation of the Society can become member of the Society Provided he fulfills qualifications and laid down the Governing Body by a majority decision .Every member will have to pay an admission fee and the Governing Body of the Society may decision membership fee as from time to time .The Governing Body may exempt and person from payment of admission and membership fee in the interest of Society .







 - ii) Active member


3 DISOQUALIFICATION

No person shall be entitled to become a member of Society if he/she:-


- a) Is an unsound mind .

- c) A person shall cease to be member of the Society in the case of :

4 REMOVAL FROM MEMBERSHIP :

Any member of the Governing Body acting detrimental to the interest of the school or institution (s) under it or not attending the three meetings continuously as stated in rule 3 or is convicting for moral turpitude or does not pay the membership fee as directed by simple majority of votes in any meeting called for this purpose .

5 GENERAL BODY :

Member from rule © shall be for the General Body Of the School, Which a regular register shall be maintained, showing each clause separately .Buy the first week of March every year ; the Gen-Secretary shall issue a list of eligible member after proper scrutiny and after proper approval of the Governing Body.


The following among others, are the functions of the Governing Body :-


- To elect the Governing Body whenever required .

6. GOVERNING BODY .


- The Governing Body shall consist of not less than 7 members .






- c) The simple majority of votes and the quorum in that meeting should be 2/3 of the general body will elect the member of the Governing Body . the notice containing time, date & place for such meeting will be issued at least three week prior to the date of meeting .
- d) The Governing Body shall elect president , Gen- Secretary, Cashier, and three Executive member from its members as the office bearers for tenure of five years .
- e) The Governing Body will be executive authority of the Society and will under take all the activities of the Society on its behalf .
- f) The Governing Body shall have the power / function of :
 - g) To admit new members in different category.
 - h) To invest the funds of Society in (a) Movable property (b) Deposit in Banks (c) Share of joint stock Companies etc.(e)
In any other securities/funds as deemed fit permitted by law
 - i) To receive funds, donations and grant-in-aid any kind of type .
 - j) To spend any money this may be necessary for carrying out the objects of the Society.
 - k) To keep records of the Society .
 - l) To appoint sub committees for various purpose in case of need subject the overall control of the Government Body .
 - m) To delegate any of its power to its President, Gen- Secretary, or any its members by a specified resolution.
 - n) The following members of the Society will be Governing Body of the Society and will be taken as founder members.

7. FUNCTION AND DUTIES OF THE PRESIDENT


- a) The President of the Society shall Preside , conduct and regulate all meeting of the Society , and to take votes to declare results of voting, determine the order in which the overall proposal shall be laid before the Committee and generally to supervise the conduct of the business . - c) To sanction expenditure within the budget. The President may in anticipation of the sanction of Governing Body to be obtained in its next meeting incur expenditure up to Rs.100000/- (Rs one lacs only) in case of emergency not covered by sanctioned budget.

In addition to the above to the powers, the governing body may be a special resolution delegate powers to the President who may Make further delegations, if considered necessary, to the Gen-Secretary or any other office bearers of the Governing Body/ Sub Committee.

- a. To finalize the agenda for all types of meetings.
- b. To accept the resignation of any member of the Governing and General Body.
- c. To admit any eligible member in case of vacancy caused by death or resignation or disqualification of any member.

8. FUNCTION AND DUTIES OF THE VICE PRESIDENT :


In the absence of the President, the Vice- President shall preside over the meeting and exercise all such powers.



- xii) To keep and maintain the necessary register /registers in connection with the account and property of the Society.



He will maintain the books of account of the Society .






11. MEETINGS

Ordinary meetings of the general body shall be held once in a year for which at least two weeks notice shall be required . the quorum of such meetings shall be $\frac{1}{4}$ of the total membership . the annual general meetings of the school shall be considering the Following subjects in the annual meetings .


- 1) Budget of the current financial year framed by the various Committees and recommended by the Governing Body .

The Governing Body shall give notice of the date , time and place of the meetings of the School at least 15 days before the date of meeting. The notice shall also contain the agenda to be laid before the meeting .

The Governing Body shall have the powers to frame bye -laws for the conduct of own business or for the School . Ordinary meetings of the Governing Body shall be held at least once in a quarter which 7 days notice will be required . special meetings shall be called whenever felt the necessary for such meetings .

A meeting of the Governing Body can be requisitioned by at least five members of the committee who shall send the requisition to the Gen-Secretary specifying agenda, which is to be taken up in this meeting. The Gen-Secretary in consultation with the President shall issue notice for the meeting with in 30 days of the receipt of requisition .

The notice of the proposal made by any member of the Society for being laid before the annual general meetings shall reach the Gen-Secretary in writing at least 10 days before the date of the meetings and the Gen-Secretary after laying it before the Governing the General Body meeting.

If on the date of which the meeting of the Society is called the number of the members present within one hour of the specified time ,is insufficient for the quorum the meeting shall stand adjourned .

A fresh notice of at least one day shall be required for calling the adjourned meeting for failure of quorum. No quorum . shall be required for such meeting.







The decision of Presiding officer on any question relating to the conduct of business of the Society shall be binding on the members unless it dissented from a majority of $\frac{3}{4}^{\text{th}}$ of the members present and voting at this meeting.


14 ACCOUNTS:


- a) The bank accounts of the Society shall be kept in the name of the Society in any of the scheduled banks and operated by the President of the Society or any other person/ member of the Society duly authorized by the President.
- b) The year of the Society for maintaining the accounts and Other purpose shall be from 1st April of a year to 31st march Of following year.


- 15 DISSOLUTION: The $\frac{2}{3}$ members of the General Body voting on this account shall dissolve the Society. After that If upon the winding up or dissolution of the Society, there remain after satisfaction of all its debts and liabilities, any property whatsoever, the same shall not be paid to or distributed among the members of Society but shall be given or transferred to some other institutions having objects similar to the objects of the Society to be determined by the members of the Society or before the time of dissolution.

16. INTERPRETATION OF REGULATIONS:


